## Affiliate terms & conditions

1. Using Affiliate code gives prospects a 10% discount off the 1st year subscription.
2. Affiliate receives an unique code to share with their contacts and network.
3. By accepting an affiliate code, affiliate indicates acceptance and agreement with all terms and conditions of the Nimble Quotes affiliate program.
4. The Nimble Quotes system gives a new subscriber using the affiliate code a 10% discount for one year when they subscribe before the end of their free trial.
5. The affiliate code tells the system to credit the affiliate with the new account when they subscribe before the end of their 30 day free trial.
6. For an affiliate to be credited with a sale, the user must subscribe within the 30 day trial period.
7. Affiliates are approved at the sole discretion of Nimble Quotes.
8. Affiliate Commission and bonus payments are aggregated and paid once each following month. Nimble Quotes accounting cutoff is the 1st business day following the 20th of each month.
9. Currency and Foreign Exchange: Nimble Quotes subscriptions are priced in US\$. Affiliates are paid US\$ except, Canadian affiliates who are paid net CDN\$.
10. Affiliate payments continue for as long as the user remains subscribed. This allows the affiliate to build up a significant continuing business.
11. Affiliates agree that subscriptions are solely owned by Nimble Quotes. The only claim an affiliate has is for commission payments.
12. Minimum Payment: Commissions are accumulated until they reach \$25. Payment made when the total payment due exceeds \$25.
13. Account cancellations or refunds are deducted from payments due an affiliate.
14. For the purposes of the Nimble Quotes Affiliate program, a month is defined as a calendar month.
15. Approval of an affiliate may be withdrawn at any time by Nimble Quotes at the sole discretion of Nimble Quotes.
16. Nimble Quotes Affiliate Program terms and conditions can be changed at any time at the sole discretion of Nimble Quotes.
17. \*Advanced monthly and Advanced annual subscriptions are the only accounts with a 50% commission offer.
